The school undertakes to abide by the provisions contained in the affiliation and examination byelaws, directions issued by time to time and the law of the land.
 8. That the school will ensure the compliance of all statutory requirements like EPF, ESI and Labor Laws etc, with respect to the school and staff of the school.
 9. That the school will ensure that the Building Safety, Fire Safety and Water Safety, Health and Hygiene certificates are being issued or renewed by the concerned municipal or state authorities from time to time as per the prescribed term.
 10. That the school will ensure that all required infrastructure is available with the school before starting classes.
